**POSITION DESCRIPTIONS** (further detail can be found in the <u>CMBES By-Laws</u>)

**President:** The President shall act as chairperson of all meetings of the Executive and the General Meeting and Special General Meetings of the Society.

**Vice-President:** The Vice-President shall be vested with all the powers and perform all the duties of the President in the absence or disability or refusal to act of the President, together with such other powers and duties, if any, as may from time to time be assigned to him/her by the Executive.

**Secretary:** The Secretary shall issue or cause to be issued notices for all meetings of the Executive and the Society when directed to do so, have charge of the minute books of the Society and record and maintain minutes of the Executive and all meetings of the Society: sign with the President or other signing officers of the Society such instruments as require his/her signature and shall perform such other duties as the terms of his/her engagement or this by-law call for, or the Executive may from time to time properly require of him/her.

**Treasurer:** The Treasurer shall have the care of all funds and securities of the Society, and shall direct the deposit of same in the name of the Society in such bank or banks or with such depository or depositories as the Executive may direct. He/she shall be responsible for the preparation and maintenance of clear financial records.

**Chair of the Membership Committee:** The Membership Committee is tasked with the review of all applications for membership and the recommendation of membership status.

Chair of the Publications Committee: The Publications Committee is tasked with all matters concerning publications of the Society, including the Newsletter.

Chair of the Professional Affairs Committee: The Professional Affairs Committee is tasked with all matters concerning establishment and maintenance of professional standards, certification procedures and liaison with other professional associations and relevant organizations.

Chair of the Awards Committee: The Awards Committee is tasked with ensuring that the Society awards and recognizes deserving individuals and organizations for their outstanding achievements and contributions to CMBES, the profession and the society at large. To this end the Awards Committee shall coordinate all matters related to all awards issued by the Society.

Chair of the Long Term Conference Planning Committee: The Long Term Conference Planning Committee is tasked with all issues regarding planning of future conferences including the establishment of a local organizing committee for the next conference. Planning for the next conference is to be handed over to the local organizing committee, normally one year before the date of the conference.

# **Professional Affairs Updates**

From the desk of the Professional Affairs Committee Chair, Andrew Ibey

The Protecting Canadians from Unsafe Drugs Act (Vanessa's Law) introduces a new power to require certain healthcare institutions to report serious adverse drug reactions and medical device incidents. This requirement is intended to improve the reporting of these types of events and enable the timelier identification and communication of emerging safety issues associated with the use of drugs and medical devices. This power will come into effect when accompanying changes are made to both the Food and Drug Regulations and the Medical Devices Regulations. The regulatory changes will define the applicable healthcare institutions, the data to be provided, and when it must be provided to Health Canada.

### **Objective**

To implement a new regulatory framework for a national mandatory reporting program, that provides comprehensive information about these types of adverse events while minimizing the operational impact on healthcare institutions.

### **Consultations**

On June 28, 2017, Health Canada released a consultation paper on <u>Mandatory Reporting of Serious Adverse Drug Reactions and Medical Device Incidents by Health Care Institutions</u>.

A Webinar was held on July 18, 2017 and was very well attended with over 200 registered participants. Please find the recent links to the summary paper from this consultation "What we heard - Responses to the public consultation paper entitled Toward mandatory reporting of serious adverse drug reactions and medical device incidents by health care institutions".

Health Canada held a series of consultations with healthcare institutions on the costs and benefits for these regulations in December and January.

There will be an online questionnaire sent out via email in the next month asking about your system requirements.

### **Proposal**

The consultation paper proposed that:

- Hospitals that provide acute care facilities be required to provide to Health Canada information in their control about serious unexpected adverse drug reactions and medical device incidents.
- Timelines for institutions to report be 30 days for both serious adverse drug reaction and medical device incident reporting.

- The regulations define both a minimum set of information data fields and a set of additional data fields to be 'required to be completed, if the information is known' to be provided to Health Canada.
  - For Medical Devices this would mean:
    - The name of the health care institution and the contact information of a representative of that institution;
    - The device name:
    - The manufacturer or importer name; and
    - A description of the medical device incident.
- The regulatory reporting time clock starts on the day on which the serious adverse drug reactions/medical device incident is first documented.

Information in the control of an institution about an adverse drug reaction could, for example, include:

- A separate reporting form (online or hard copy) completed by a health care professional, or
- A serious unexpected adverse drug reaction that is identified by a health care professional in a patient's clinical record.

The scope of therapeutic products to which these reporting requirements apply would include:

- Pharmaceuticals (prescription and non-prescription)
- Biologic drugs (that are not vaccines)
- Radiopharmaceuticals
- Disinfectants
- Medical devices (all types)

### **Definition**

Medical device incident – [...] related to a failure of the device or a deterioration in its effectiveness, or any inadequacy in its labelling or in its direction for use; and has led to the death or a serious deterioration in the state of health of the patient, user or other person, or could do so were it to recur.

Please note that the final regulatory proposal will be informed in part by the input received through the consultations. As such, the regulatory proposal may evolve prior to publication in the Canada Gazette.

### **CMBES 2018 Travel Grant Call for Applications**

The International Outreach Committee of CMBES is pleased to announce a travel grant in aid of supporting volunteer work in Clinical Engineering. This grant is intended to partially defray the travel costs of a Clinical Engineer, Biomedical Engineering Technologist, or Clinical Engineering student, **who is a CMBES member** and a Canadian Resident, who is planning to travel to a developing country to do volunteer work related to Clinical Engineering within the next year.

A grant of \$1500 will be awarded to a qualified candidate. Applicants are expected to cover at least half of the costs of the proposed volunteer activity through fundraising efforts or out-of-pocket payment by the participant and their family. The CMBES Travel Grant is meant to partially cover travel costs.

Application can be made for funding to support travel that will commence before April 15 2019. Further details can be found on the application form.
